supporter of 4Kids of South Florida and His House Children's Home, two foster agencies dedicated to providing love and stable families to the foster children of South Florida. In addition, Ms. Quesada provides pro bono legal services to individuals who are having financial difficulties and losing their homes to foreclosure, as well as other legal hardships they may be facing.
